

**RewardsPLUS Sweepstakes

Official Rules

No purchase necessary. A purchase will not increase your chances of winning.

**Eligibility**

The RewardsPLUS Swipe to Win Sweepstakes (the “Sweepstakes”) is open only to individuals who are at least eighteen (18) years of age. Employees of F.L. Roberts and Company, Incorporated (“F.L. Roberts”) or other companies related to or affiliated with F.L. Roberts, as well as the immediate family of each such employee, are not eligible to win. Void where prohibited by law.

**Agreement to Official Rules**

In addition, you indicate your full and unconditional agreement to, and acceptance of these official rules and Sponsor’s decisions, which are final and binding. **Term**

1. *Enter in Store:* If you are a RewardsPLUS cardholder, you may enter by presenting your RewardsPLUS card or the phone number associated with your RewardsPLUS card in conjunction with a purchase at a participating F.L. Roberts location.

2. *Enter by Mail:* If you do not have a RewardsPLUS card or would like to enter without a purchase, mail a 3x5 inch postcard with your name, age, address & telephone number in an envelope to: F.L. Roberts / Swipe to Win Sweepstakes/PO Box 1964, Springfield, MA 01102-1964. Only one entry per envelope. More than one entry may be submitted each month. Entries must be received prior to the end of a calendar month in order to be eligible for that month's drawing. Drawings will be held the following month as hereinafter described. Entries will not be acknowledged or returned.

### **Prizes**

Winners are responsible for paying any applicable taxes and any and all other costs and expenses not included with the prize. ### **Winner Selection**

Potential winner(s) will be selected in a random drawing from among all eligible entries received for each month while the Sweepstakes is in effect, on or about the fifth (5<sup>th</sup>) day of the month immediately following the end of each month during the Sweepstakes is in effect, from among all eligible entries received in the preceding month. The drawing will be conducted by the Independent Sweepstakes Administrator. All decisions of Sponsor are final. Odds of winning each prize are dependent upon number of eligible entries submitted and received.

### **Drawings**

All entries received within the calendar month's entry period will be eligible for that month's Sweepstakes. These entries will also be eligible for the monthly grand prize and quarterly grand prize for that entry period. After the month/quarter is complete, the entries will be removed and only those entries meeting the current calendar requirement will be eligible.

Drawings will occur on/around five (5) days after the end of each month of the entry period. Quarterly winners will be drawn in January, April, July and October.
